The Steps help us and the Traditions help us work as a group.

Twelve Traditions

- 1. Our common welfare should come first; personal progress for the greatest number depends upon unity.
- 2. For our group purpose there is but one authority—a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants—they do not govern.
- 3. The relatives of alcoholics, when gathered together for mutual aid, may call themselves an Al-Anon Family Group, provided that, as a group, they have no other affiliation. The only requirement for membership is that there be a problem of alcoholism in a relative or friend.
- 4. Each group should be autonomous, except in matters affecting another group or Al-Anon or AA as a whole.
- 5. Each Al-Anon Family Group has but one purpose: to help families of alcoholics. We do this by practicing the Twelve Steps of AA *ourselves*, by encouraging and understanding our alcoholic relatives, and by welcoming and giving comfort to families of alcoholics.
- 6. Our Family Groups ought never endorse, finance or lend our name to any outside enterprise, lest problems of money, property and prestige divert us from our primary spiritual aim. Although a separate entity, we should always co-operate with Alcoholics Anonymous.
- 7. Every group ought to be fully self-supporting, declining outside contributions.
- 8. Al-Anon Twelfth Step work should remain forever non-professional, but our service centers may employ special workers.
- 9. Our groups, as such, ought never be organized; but we may create service boards or committees directly responsible to those they serve.
- 10. The Al-Anon Family Groups have no opinion on outside issues; hence our name ought never be drawn into public controversy.

- 11. Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio, films, and TV. We need guard with special care the anonymity of all AA members.
- 12. Anonymity is the spiritual foundation of all our Traditions, ever reminding us to place principles above personalities.
